 Rule 5.8 Gift Limits for Legislative Liaison or Legislative
 Lobbyist.

5 A legislative liaison or a legislative lobbyist may make a Α. 6 gift to the Governor or any legislator or any employee of the 7 Governor or the Legislature in recognition of infrequently 8 occurring occasions of personal significance. The gift shall be 9 given and received contemporaneously with the occasion or at 10 times when such gifts are traditionally given. Such gifts may 11 be made to a family member of the Governor or any legislator or 12 any employee of the Governor or the Legislature, provided such 13 family member is a party to a marriage, serious illness, birth 14 or adoption of a child or retirement. Such gifts to any 15 individual recipient may not exceed One Hundred Dollars 16 (\$100.00) in the aggregate in any calendar year from any 17 legislative liaison or legislative lobbyist.

<u>B.</u> Informational materials, such as books, written materials,
<u>electronic</u>, audio and/or video materials, and similar
<u>informational materials may be provided to the Governor</u>, or any
<u>Legislator</u>, or any employee of the Governor or Legislature,
<u>provided such informational materials are related to the</u>
<u>recipient's duties as an officer or employee of the State of</u>
Oklahoma.

 liaison or legislative lobbyist may not exceed Five Hundred
 Dollars (\$500.00)

8 Rule 5.11. Gift Limits for Executive Lobbyist.

9 An executive lobbyist may make a gift to a state officer or Α. 10 employee of an agency for which he or she is registered or 11 should be registered as an executive lobbyist in recognition of 12 infrequently occurring occasions of personal significance. The 13 gift shall be given and received contemporaneously with the 14 occasion or at times when such gifts are traditionally given. 15 Such gifts may be made to a family member of a state officer or 16 employee of an agency for which he or she is registered or 17 should be registered as an executive lobbyist, provided such 18 family member is a party to a marriage, serious illness, birth 19 or adoption of a child or retirement. Such gifts to any 20 individual recipient may not exceed One Hundred Dollars 21 (\$100.00) in the aggregate in any calendar year from any 22 executive lobbyist.
